**ORDER CONFIRMING  
PARTIES' STIPULATION OF FACT  
AS TO CLASS SIZE**

A telephone conference having been held on the record on February 27, 2013 which was scheduled based on Plaintiff's February 26, 2013 letter request [ECF No. 39] with Philip D. Stern, Esq. appearing for Plaintiffs, and Mitchell L. Williamson, Esq. and Michael Jon Peters, Esq. for Defendant, and Defendant's attorneys having had the opportunity to discuss the letter; and the letter having asserted, among other things, Defendant's discovery responses represented there to be 75 individuals satisfying Plaintiffs' proposed class definition while Defendant's February 25, 2013 opposition [ECF No. 38] to Plaintiffs' Motion for Class Certification [ECF No. 31] represented there to be 31 individuals satisfying Plaintiffs' proposed class definition; and, in resolution of the asserted disparity in

class size, the parties stipulate as follows:

1. Defendant does not dispute Plaintiffs' assertion that they have met the requirement for numerosity under Fed. R. Civ. P. 23.

2. If the class is certified, there are 75 individuals who fit the class definition.


